I am writing in response to your request for information under the Freedom of Information Act 2000, received 07 August 2019. Our response is provided below:

I am looking for information relating to staff absence due to mental health. I would like figures by financial year for the number of firefighters and civilian employees absent due to mental health related illness within your fire service.

Q1 In 2018/19 please provide data on the number of cases, number of days of absence, total days and total average staff, as per the methodology of the previous response provided by London Fire Brigade.

In Northamptonshire Fire and Rescue Service (NFRS), our mental health reporting categories include: stress, anxiety, mental health and depression. Please refer to the table below:

Please note, we are unable to apply the same methodology as a previous response provided by another Fire and Rescue Service as we utilise different systems to record the data and can only report on the information we hold and the format it is recorded in for NFRS.
