## Re: Request for information (our ref: NFRS2019-136-150)

I am writing in response to your request for information under the Freedom of Information Act 2000, received 23 December 2019. Our response is provided below:

For the questions below, please provide data for the period 01 January 2016 to 30 November 2019:

Q1 What is the number of flood-related incidents attended?

Flooding incidents are a Special Service type incident. They are not categorised according to cause or source of flooding. We have therefore searched our database for the following initial incident types: 'Flooding in building', 'Flooding in the open' and 'Flooding in the open - rescue'. Please refer to the table below for the totals of those incidents recorded by Northamptonshire Fire and Rescue Service (NFRS):
