I am writing in response to your request for information under the Freedom of Information Act 2000, received 10 January 2020. Our response is provided below:

Q1 Please provide details of all expenses claimed by your Chief Fire Officer in each of the of the following financial years; 2018-19, 2017-18 and 2016-17 along with scanned copies of the receipts provided when the claim was made

Any business expenses claimed by our Chief Fire Officer for the financial years 2016-17, 2017-18 and for April – December 2018 were through a Government Procurement Card (GPC). That data was published on the Northamptonshire County Council (NCC) website under their <u>Transparency</u> section > Open data – our publications > <u>Government</u> <u>Procurement Card transactions</u> or can be requested from <u>NCC</u>.

From 01 January 2019, the governance of Northamptonshire Fire and Rescue Service (NFRS) transferred to the Office of the Police, Fire and Crime Commissioner (OPFCC). We are applying an exemption under Section 22 of the Act as the GPC transactions from this date will shortly be published on our website: <u>www.northantsfire.gov.uk</u> > About us > Publication of Information > What we spend and how > <u>NFRS spends</u>.

No personal expenses were claimed by our Chief Fire Officer during the period requested.
