- Q1 Who is the supplier/provider of the services?

The supplier to Northamptonshire Fire and Rescue Service (NFRS) is Solo Service Group.

Q2 What is the total annual spend?

NFRS' total annual spend for office and building cleaning is £97,396.68.

Q3 Provide a description of the services provided under this contract, please include information if other services are included under the same contract.

Solo Service Group provide daily cleaning of all NFRS sites.

Q4 What is the number of sites the contract covers?

There are 23 buildings in total.

Q5 What is the start date of the contract?

The current contract started on 01 September 2017.

Q6 What is the end date of the contract?

The current contract is due to end on 31 August 2021.

Q7 What is the duration of the contract? Please include information on any extension periods.

The Solo Service Group contract is 3 years, a further year extension has been included.

Q8 Who within the organisation is responsible for the contract? Name, job title, contact number and email address.

B) Lift service and maintenance – Service contract for lift service and maintenance.

There are no lifts on NFRS premises and therefore we do not have a contract for lift servicing or maintenance.

C) Food – Service contract that is focused around catering services.

Catering requirements are requested on an ad-hoc basis, there are no contracts in place. The catering provision is to be withdrawn from NFRS therefore no contract will be put in place for future requirements.

- D) General waste services contracts the organisation's primary general waste service contract.
- Q1 Who is the supplier/provider of the services?

The supplier to NFRS is Veolia.

Q2 What is the total annual spend?

NFRS' total annual spend for general waste services is £12,078.

Q3 Provide a description of the services provided under this contract, please include information if other services are included under the same contract.

Waste management of all NFRS sites.

There are 23 buildings in total.

NFRS do not hold this data as the initial contract was taken out by Northamptonshire County Council (NCC) when NFRS came under their governance arrangements.

The current contract is due to end on 30 April 2021.

Due to not holding the initial contract start date, we are unaware of the full duration of the contract.

The suppliers to NFRS are:

- Ward Workwear
- Johnsons Workwear
- Bristol Uniforms
- Q2 What is the total annual spend?

NFRS' total annual spend relating to laundry services and roller linen towels only between April 2019 and March 2020 was £45,196.82, split between the suppliers is as follows:

- Ward Workwear Laundry and cleaning uniforms = £1,181.39
- Johnsons Coverall contract and roller towel rental = £18.560.67
- Bristol uniforms Laundry fire trousers and coats = £25,454.76
- Q3 Provide a description of the services provided under this contract please include information if other services are included under the same contract.

Laundry services, roller towel supply, washing of Personal Protective Equipment (PPE).

Q4 What is the number of sites the contract covers?

There are 23 sites in total.

Details are provided below for NFRS suppliers of laundry services:

- Ward Workwear there is no contract in place
- Johnsons Workwear there is no contract in place
- Bristol Uniforms the current contract started on 04 March 2019

Q6 What is the end date of the contract?

Details are provided below for NFRS suppliers of laundry services:

- Ward Workwear there is no contract in place
- Johnsons Workwear there is no contract in place
- Bristol Uniforms the current contract is due to end on 01 March 2027

For the suppliers of NFRS laundry services, this is not applicable for Ward Workwear and Johnson Workwear as no contracts are in place. The duration of the Bristol Uniforms contract is 8 years.
