## Re: Request for information (our ref: NFRS2021-62-69)

I am writing in response to your request for information under the Freedom of Information Act 2000, received 15 July 2021. Our response is provided below:

Q1 Please could you provide me with the number of fires in which hoarding has been a factor from 2017 to the most recent year available? Please break the information down into separate years?

Hoarding is not recorded as a factor on the Home Office's Incident Recording System (IRS), so we have performed a search on our IRS free text fields for all incident notes which contained hoard/hoarding/hoarder etc.

Please note that these are only the incidents where hoarding was noted on IRS free text fields – there may have been incidents where hoarding was a factor but was not recorded (in IRS free text).

Q2 If there have been any serious case reviews following a fire, please could you also provide this information? If hoarding was a factor, please mention this if the information is available.

Northamptonshire Fire and Rescue Service (NFRS) call serious case reviews: 'Community Impact Assessment (CIA) reviews'. There is one CIA review where hoarding was recorded as a factor. We are unable to provide full details of this CIA as it would potentially identify an individual; as such we have taken the exemption under Section 40(2) of the FOI Act. A copy of any redacted IRS reports are not covered under the FOI Act as it is a chargeable service. Our <u>chargeable service fees</u> and the procedure for <u>requesting a copy of an incident report</u> are available on our website.

Q3 Could you tell me what kind of information (e.g. mapping) you hold regarding properties/locations that a fire risk owing to hoarding and if you are able to quantify this then please provide that data; e.g. numbers of properties within your area known to be occupied by someone with hoarding tendencies.

We record person centred information, where we make a referral on behalf of someone due to levels of clutter/hoarding affecting their health, safety or wellbeing on our Community Fire Risk Management Information System (CFRMIS).

We also record on our mobilising system, premises information where hoarding/clutter levels represents a risk to operational firefighters via our Pre-Determined Attendance (PDA) request/change form process. This information is refreshed and reviewed so collating the number gives us a live picture of the scale of current and known hoarded properties.

We have 177 properties in Northamptonshire that we are currently aware of where hoarding is a significant risk. We only keep this information if there is a significant risk to the safety of the occupier, or to the safety of the fire crews when attempting to access the property in the event of an emergency.
