Re: Request for information (our ref: NFRS2022-44-44)

I am writing in response to your request for information under the Freedom of Information Act 2000, received 07 April 2022. Our response is provided below:

How many (a) Wholetime Firefighter, (b) Retained firefighter, (c) Fire control room, (d) Support staff and (e) Total staff there were employed in your Fire and Rescue Service, measured by headcount, on 31 March 2021 and 31 March 2022?

We are exempting the headcount of staff recorded on 31 March 2021 under Section 21 of the Act [Information reasonably accessible to applicant by other means] as this information is publicly available via the Home Office's Fire statistics data tables > Workforce and workforce diversity > FIRE1101: Staff in post employed by fire and rescue authorities by headcount and full time equivalent by role and fire and rescue authority. On the tab titled 'FIRE1101', enable editing on the spreadsheet itself and then you can change the drop down from 'England' to 'Northamptonshire' to view the data requested.

We are exempting the headcount of staff recorded on 31 March 2022 under Section 22 of the Act [Information intended for future publication and research information] as this information is due for future publication by the Home Office and will be available to access via the link provided above.

Q2 How many (f) Wholetime firefighters employed by your fire and rescue service as of 31 March 2021 and 31 March 2022 (headcount) that also work a retained contract, and therefore could be described as "Wholetime-Retained". We only request the number of Wholetime firefighters with an additional Retained contract – we are not asking whether it is with your own or another fire and rescue service.

As of 31 March 2021, Northamptonshire Fire and Rescue Service (NFRS) recorded 48 wholetime firefighters who also held a retained contract.

As of 31 March 2022, NFRS recorded 51 wholetime firefighters who also held a retained contract.
